Description of Noncompliance:

Description of the Audi has determined that the rearview camera software in vehicles included in

Noncompliance: this recall was not successfully updated when the vehicle had Audi recall code 91CR performed. As a result, under certain operating conditions, the response

time of the rearview camera image might not meet requirements of FMVSS 111

when tested according to S14.2.

FMVSS 1: 111 - Rear visibility

FMVSS 2: NR

Description of the Safety Risk: A rearview camera picture that might not be available when beginning to

back up which might impair the driver's ability to see areas to the rear of the

vehicle in time. This can increase the risk of a crash.

Description of the Cause: Due to an issue within the flash code of the software update routine when

affected vehicles were updated under Audi recall code 91CR, the software of

the control unit for infotainment was not updated even though the scanner tool erroneously showed a positive result of the update (scanner showed false positive).

Chronology:

October 29, 2021: Start of Audi recall 91CR/NHTSA 21V-825 in the U.S. market.

January 19, 2022: After communicating with a dealer, Audi AG identified that the software update being provided under Audi recall 91CR was not performed correctly in some vehicles. Audi AG started an investigation. A deviation in the flash code for one specific model (Audi Q3) was discovered and corrected. Other models included in Audi recall 91CR have been checked and are not affected.

January 31, 2022: The Audi Product Safety Committee determines that the affected vehicles may not fully conform to FMVSS111 under certain conditions. Hence, a voluntary non-compliance recall was decided.

As of February 04, 2022 Audi is not aware of any warranty claims or customer claims due to this issue.

Description of Remedy:

Description of Remedy Program: At no cost to customers, the control unit for infotainment will receive an

updated set of parameters. Because the vehicles are within the New Vehicle Limited Warranty period, Audi will not offer a reimbursement

program under this recall.

How Remedy Component Differs Vehicles with the remedy software will allow rear view camera operation

from Recalled Component: fully compliant with the requirements of FMVSS 111; Rear visibility.

Identify How/When Recall Condition This recall only affects certain vehicles where the software update under was Corrected in Production: recall 91CR was not successful. Vehicles produced on or after October 16,

2021 have received software that ensures compliance with FMVSS 111; Rear visibility. Where possible, vehicles produced before that date have

already received the updated software in the factory or port.
