• On March 28, 2023, the FCA US LLC ("FCA US") Technical Safety and Regulatory Compliance ("TSRC") organization opened an investigation into 2023 MY Chrysler Pacifica PHEVs that were built with an improperly extruded fuel line.

• From March 2023, through June 2023, FCA US TSRC conducted an analysis of fuel line leaks, vehicle histories, and reviewed supplier data.

• As of July 5, 2023, FCA US has identified zero customer assistance records, two warranty claims, and zero field reports potentially related to this issue for all markets with dates of receipt ranging from April 25, 2023, through June 2, 2023.

• As of July 5, 2023, FCA US is not aware of any accidents or injuries potentially related to this issue for all markets.

• On July 14, 2023, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or
	other adequate proof of payment to the company for confirmation of the expense.
