**Descriptive Information :** Jaguar Land Rover is conducting a voluntary safety recall campaign involving 2024 Land Rover Discovery Sport vehicles built at the Halewood Vehicle assembly plant from November 10, 2023 - January 23, 2024. 47 vehicles in the United States and Federalized Territories. The recall population was determined by reviewing build records of vehicles where the righthand-side lower A-pillar bolt may not have been fastened to the correct torque on some body shells. .

**Description of the Defect :** A concern has been identified where the righthand-side lower A-pillar bolt may not have been fastened to the correct torque on some body shells. For 7 seat vehicles, it is possible that the body structure may not perform as intended in certain crash modes.

## Chronology :

On 06 February 2024, the vehicle assembly plant team discovered through inspection of vehicle build data that a number of vehicles may have been built with the lower A-Pillar bolt on the righthand-side improperly fastened. A stop-shipment was implemented by the vehicle assembly plant and an Update Prior to Sale (UPS) notice issued to affected retailers to suspend the sale of affected vehicles until corrective actions were applied. The Product Safety and Compliance Committee (PSCC) was informed of the issue.

On 13 February 2024, the issue was introduced to the Product Safety and Compliance Committee (PSCC) where confirmation was provided that a number of vehicles had been sold in an unrepaired state.

On 22 February 2024, JLR's Recall Determination Committee (RDC) determined that the issue presented an unreasonable risk to safety and requested that a safety recall be launched to remedy the affected vehicles.

## Description of Remedy :

Description of Remedy Program : Vehicles will have the righthand-side lower A-pillar bolt fixing checked and, if necessary, secured. There will be no charge to the owners for this repair. The affected vehicles will be covered under Jaguar Land Rover's new vehicle warranty program. Therefore, reimbursement for pre-notice remedies are not necessary because the affected vehicles are still under warranty.
