Chronology :

In mid-June 2021, a RRAB inflator in three 2015 model year Silverado vehicles—one in Florida and two in Texas—ruptured while the vehicle was unoccupied and not in use. In all three inflators, the steel inflator-body sidewall split open, suddenly releasing the gas stored inside the chamber.

GM became aware of these three incidents on June 15, June 21, and June 22nd. On June 24, 2021, GM's Safety and Field Action Decision Authority decided to conduct a safety recall. Key Safety Systems, the supplier at the time of manufacture, is now Joyson Safety Systems.
