Description of Defect :

Description of the Defect :	This safety recall involves the mounting of the horn. The horn is fixed with a screw, which may not be of sufficient length to allow an adhesive to perform as intended. Over time, this could allow the screw to loosen and, eventually, cause the horn to partially detach from the motorcycle frame. Although the horn is still attached by the electrical wiring, it could nevertheless interfere with steering.

On August 22, 2022, BMW became aware of an incident in Germany involving a 2022 BMW CE 04. It was reported that the steering may have become blocked, and that the rider was not able to control the motorcycle which resulted in a crash. An immediate analysis was initiated.

The analysis indicated that the steering had become blocked as a result of a horn which had become partially detached from the motorcycle. The analysis also indicated that the mounting hardware for the horn on the subject motorcycle may not have been appropriate. Further evaluations of engineering drawings and specifications determined that the mounting hardware for similarly produced models may not have been appropriate.

On September 1, 2022, BMW decided to conduct a voluntary safety recall.

BMW has not received any reports, nor is BMW otherwise aware, of any further accidents or injuries associated with this issue.
