ACTION/SUMMARY INFORMATION

Action: A Preliminary Evaluation (PE) has been opened.

Summary:

The Office of Defects Investigation (ODI) has received 14 complaints alleging failure to open the door on model year 2023 Fisker Ocean vehicles manufactured by Fisker Group Inc. The complaints allege an intermittent failure of the latch and handle preventing the opening of the driver, front passenger and/or rear doors. Some reports allege the inability to open the door from either the interior or exterior door handle, resulting in the need to use another door to egress. The reports allege that the emergency override mechanism also fails to open the door. Some of the 14 ODI reports did not mention these allegations in the report and instead made ODI aware during consumer outreach after the report was submitted.

ODI is opening this Preliminary Evaluation (PE) to determine the scope and severity of the potential problem
