# **Description of Noncompliance :**

A concern has been identified on certain 2021MY to 2024MY Jaguar I-PACE vehicles where the electrical loads should make the double speed tick-tock and tell-tale flash at double rate, in an electrical failed state, the double speed will not operate, the tell-tale and tick tock will flash at normal rate.

Absence of warning of electrical failure of the rear turn signal/direction indicator, may result in the driver being unaware of a failure. If the driver is unaware of a failure, this may result in the vehicle being operated with a failed turn signal/direction indicator, the turn signal/direction indicator not being seen by following vehicles and, therefore, increasing the risk of a crash.

#### Chronology :

A Product Safety and Compliance Committee (PSCC) investigation was opened on 03 January 2024 following a report of a concern with incorrectly functioning turn signal/direction indicator failed state operation. The PSCC requested an engineering team to fully define the scope of this issue. They reported their initial findings to the PSCC on 24 January 2024.

On 13 February 2024, the PSCC discussed the scope along with exposure and vehicle disposition. Based on the feedback provided, the PSCC progressed the issue to the Recall Determination Committee (RDC) for review.

The RDC reviewed the issue on 20 February 2024 and concluded that the issue represented a compliance defect and requested that a safety recall be launched to remedy the affected vehicles.
