Description of the Defect: Due to a supplier manufacturing error, one of the joint connection points of the

right front lower control arm (LCA) to the vehicle's crossmember may have been improperly welded. Over time, an improperly welded joint can fatigue

and break causing a partial separation of the LCA from the vehicle's

crossmember.
