August 2022: Volkswagen received information about a potential deviation in the flash process at a U.S. port facility. Analysis started.

September 2022: internal review indicated that some vehicles with an incorrect software level were not stopped in the port of Emden, and therefore were potentially shipped to the U.S. Analysis was started in order to locate potentially affected vehicles and to evaluate regulatory impact.

September 29, 2022: Topic was discussed in Volkswagen's Pre-Product Safety Committee.

October 05, 2022: Topic was discussed in Volkswagen's Product Safety Committee and a recall was decided. The decision is based on 5 vehicles with potentially incorrect software for the rearview camera.
